Intellectual property

Copyright I

Definition	Works of literature and art (including software)
Criterion 1	Creation of the (human) mind, literary or artistic
Criterion 2	Individual character (originality)
Photographs	Even if they do not have an individual character

Intellectual property

Copyright II

Principle	From the creation of the work
Duration	70 years after death of author (50 for software) 50 years from photograph if no individual character
Fees	None
Examples	Films, characters, website Source code (but not algorithms)

Intellectual property

Copyright III

Moral rights

Link between author and work:

- Credited
- Integrity of the work
- Access to and show the work
- Protection against destruction

Economic rights

Possibility to generate income from work:

- Reproduction
- Distribution of copy
- Representation etc

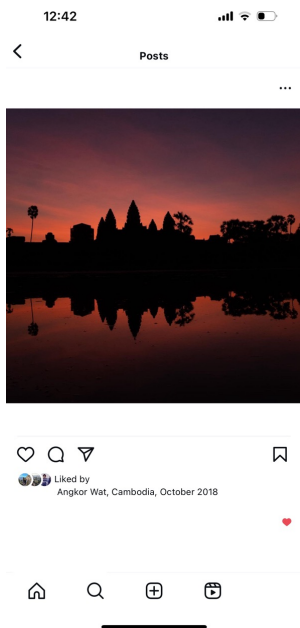

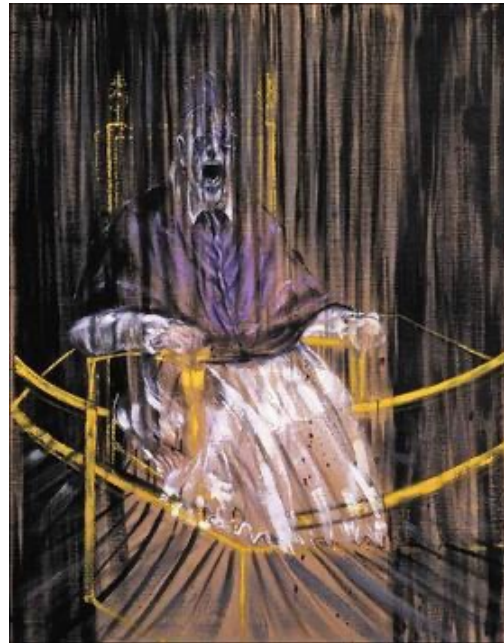
