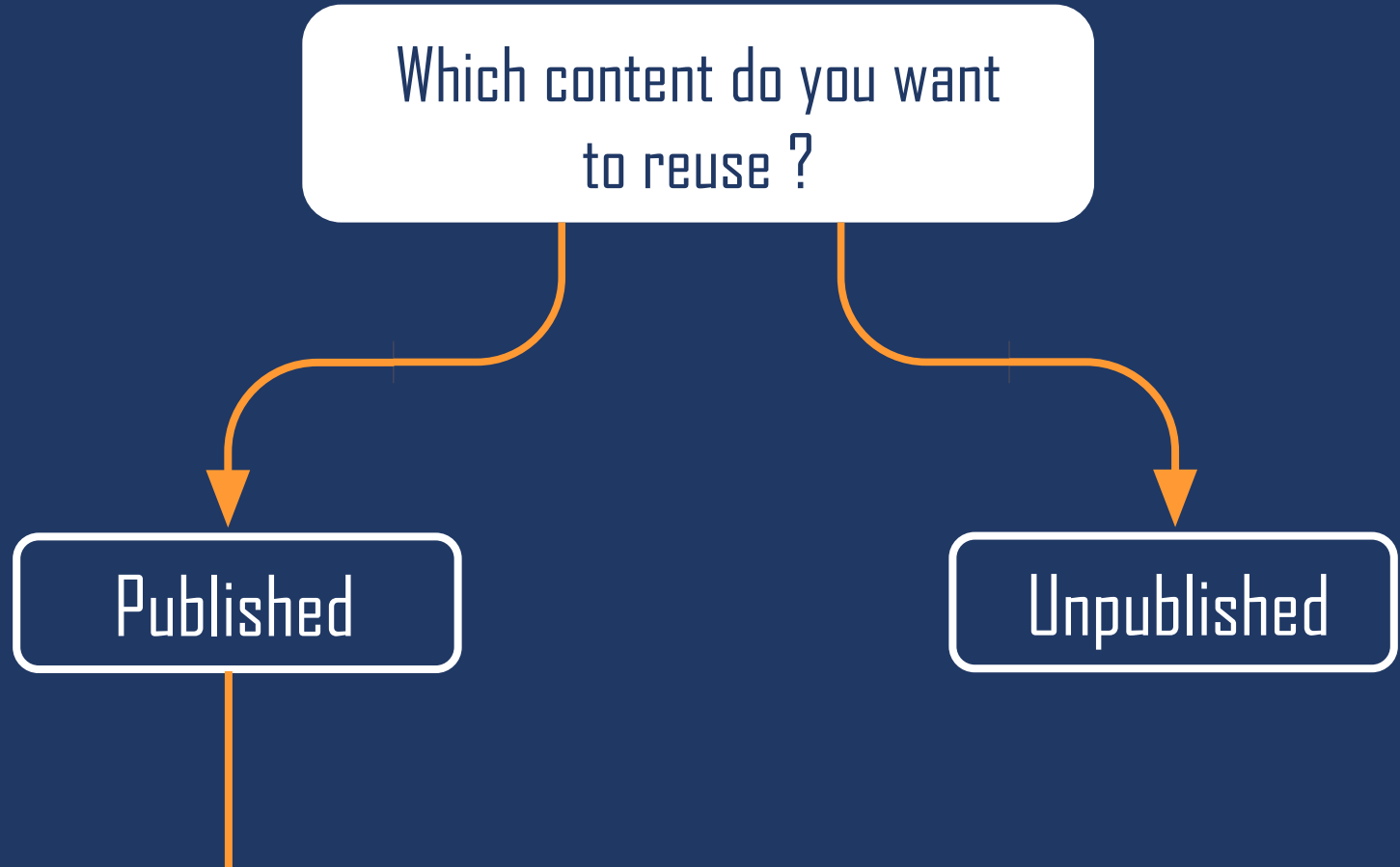
- The author is the copyright owner of his/her thesis.
- She/he is responsible for its content
 - [Ordinance on the doctorate](#)
- PhD theses are also subject the “Directive concerning the citing and referencing sources of information in written work submitted by students” ([LEX 1.3.3](#)).
- The author can decide to publish his/her thesis under a Creative Commons license.
- A thesis is considered as a non-commercial publication.

Swiss law: [Federal Act on Copyright and Related Rights](#) (1992-2023)

- In copyright laws, every author is a co-author and copyright owner. There is no concept of « corresponding author » or « first author ».
- In many cases, the copyright owner of an article will be the publisher because of the “Copyright Transfer Agreement” signed by authors.
- Regarding citation and reuse, there is no essential difference between your own work and works created by someone else.
- Citation is a right for everyone, listed as an exemption in the Swiss law. It means a right to cite works and to quote them (small extracts). Citation is also an important part of scientific integrity.

- **Citation** is a right for everyone, but **reusing** is not.
- Reusing means reproducing a work (or an important part of it) in another one. Reusing is not an automatic right: it can be retained by the author(s), surrendered to a publisher (in the publishing agreement), or defined in a specific license (CC or other).
- Reusing a work often requires a permission formally granted by the rights holder.
- Important : images (figures, illustrations, graphs, etc.) are considered as works in themselves.
- **You must properly cite the works you are reusing.**

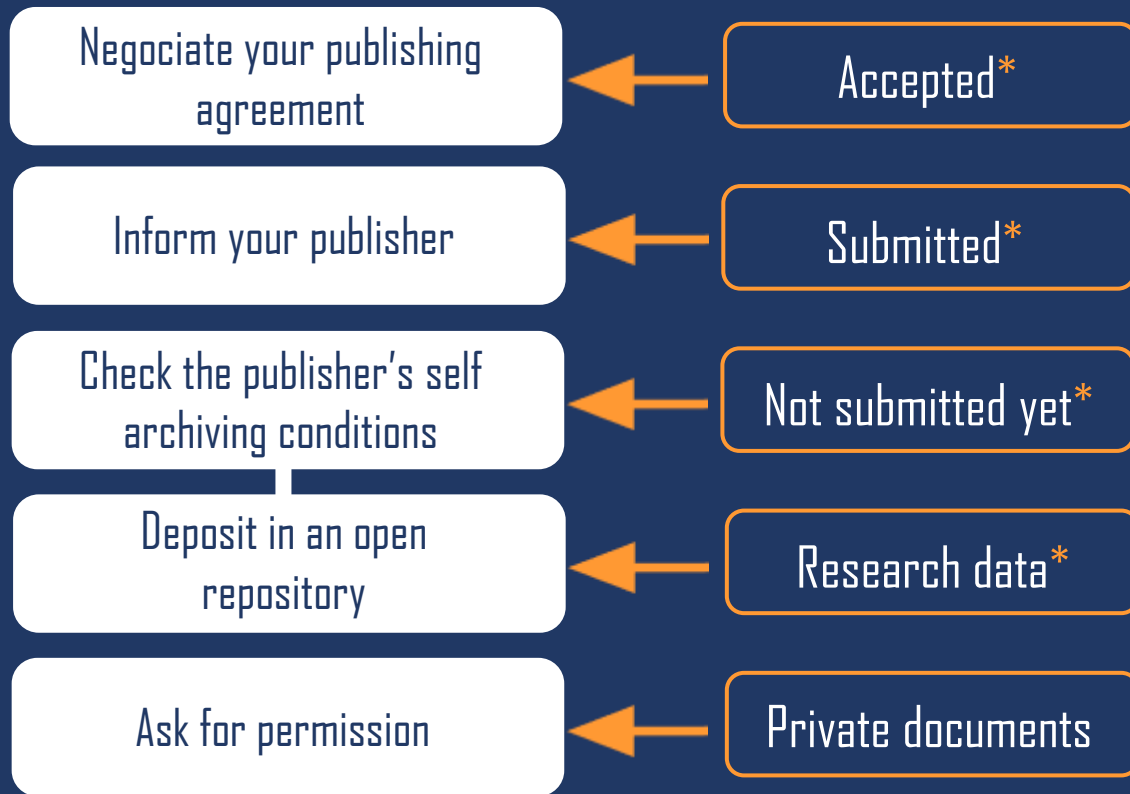

* It is recommended to reuse content that your readers can access. When possible, it is better to deposit the content in Infoscience or another open repository (arXiv, Zenodo, etc.).

Theses made of published articles

- A thesis containing a compilation of articles published (or submitted for publication) in scientific journals is possible on condition that it meets certain requirements defined by the Doctoral School :

“A thesis containing a compilation of articles published (or submitted for publication) in scientific journals is possible on condition that it contains:

- *an introduction that puts the whole thesis into context and gives a global objectives of the research to be presented in the thesis (a thesis must have a common thread that connects the different papers/chapters together).*
- *a general conclusion chapter, summarizing the main contributions of the thesis*
- *a section presenting possibilities for future development of the work presented in the thesis*

Each section that was, or is to be, published as an article must comprise on its first page

- *a complete list of authors*
- *a detailed description of the doctoral candidate’s contribution*
- *a full bibliographic reference available”*

(~40% of EPFL PhD theses used this format in 2024)

How to choose the right license?

- How to apply a CC license to a thesis?
 - The reference to the license must be included in the thesis itself (for example on the title page or in the legal notice). The reference must contain at least the authors' name, the date of publication and the URL of the license; the CC logo is optional (<https://creativecommons.org/about/downloads/>)
- Is it possible to publish a thesis under CC license if copyrighted content has been used?
 - Yes, but the copyrighted content should be clearly excluded from the application of the license

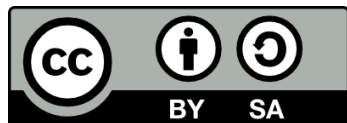
